 - **Bill Updates:**
 - AB 1816 The Reentry Housing and Workforce Development Act – capped at end
 - SB 990 Parole: County of Release – on Governor’s desk
 - SB 864 Tyler’s Law – signed by Governor
- “New” bills:
- AB 2167 Alternatives to Incarceration – on Governor’s desk
 - AB 2343 BSCC – on Governor’s desk
 - AB 2383 Ban the Box – did not make it out of Suspense File
- **Follow-up from August meeting:**

- In-custody deaths: follow up from jail workgroup meeting (Jen)
 - No update
 - SB 629 – implementation updates – feedback from CDCR (pending September update)
 - no updates
 - MAT implementation in jails (Robert)
 - completed consulting role for the Sheriffs – was a positive result
 - MAT will work *and* save lives – it just needs to be utilized
